ALL CASES.

Pursuant to the Order Regarding Registration of ASR Related Cases and Claims, all counsel for any ASR-related case pending in this Court were directed to prepare a Registration Declaration and Registration List identifying all clients with filed and unfiled ASR XL, ASR Resurfacing and/or Hemiarthroplasty claims, whether or not involving a Revision Surgery, in the format specified on Exhibit A, on or before January 6, 2014. (Doc. No. 637, Ex. A at ¶¶ 1-2).

All counsel are reminded of their obligations under the Order to update any change in the status of any Plaintiff or Unfiled Claimant identified on their Registration List. (*Id.* at ¶ 2.F). These updates must be served upon the Claims Processor on June 1 and November 1 of each calendar year following the service of the initial Registration List, and the updating requirement shall cease on June 1, 2015. The updated reports must include changes in status to both unrevised Plaintiffs and Unfiled Claimants and revised Plaintiffs and Unfiled Claimants with subsequent additional revision surgeries.

Attached Appendix A is a listing of all counsel and their clients/plaintiffs who have not registered as required by the Court's November 22, 2013 Order.

All counsel listed in Appendix A shall comply with the Order Regarding Registration (Doc. No. 637) no later than September 15, 2014.

Failure to register by this deadline will result in a Show Cause Order requiring counsel to show why they should not be held in contempt for failure to comply with the November 22, 2013 Order (Doc. No. 637) and this Order.
