In 1983, the Ohio State Bar Association, the Ohio Attorney General and the American Civil Liberties Union of Ohio Foundation collaborated to create the Ohio Mock Trial Program to give Ohio high school students opportunities to learn about their constitutional rights and responsibilities. The Supreme Court of Ohio became a Sustaining Sponsor in June, 1988.

In 1989, the Ohio Mock Trial program expanded into Ohio Center for Law-Related Education to support additional services including teacher professional development opportunities and creation of new civics and law-related programs and services for Ohio's middle and high school students.
