
Pursuant to Administrative Order 2016-18, Jonathan D. Greenberg has been selected as the new magistrate judge for the U.S. District Court for the Northern District of Ohio and will be located in Cleveland, Ohio. Magistrate Judge Greenberg entered on duty August 18, 2016, and shall be placed on the civil, social security, and habeas corpus case draws on August 29, 2016, and the criminal draw on September 19, 2016. Magistrate Judge Greenberg will also participate with all of the other eastern division magistrate judges in the Magistrate Judge Arraignment Protocol.

In order to establish a docket for the new magistrate judge, the reference of cases that had been referred to Magistrate Judge Nancy A. Vecchiarelli, whose retirement was effective on July 22, 2016, are hereby withdrawn and are referred to Magistrate Judge Greenberg. (List of referred cases needing reassignment attached.)

Section 636(c), they should complete and electronically file with the Clerk of Court a Consent to Exercise Jurisdiction by a United States Magistrate Judge form by Friday, September 2, 2016.
