Pursuant to Administrative Order 2016-22, David A. Ruiz has been selected as the new magistrate judge for the U.S. District Court for the Northern District of Ohio and will be located in Cleveland, Ohio. Magistrate Judge Ruiz entered on duty October 1, 2016, and shall be placed on the civil, social security, and habeas corpus case draws on Monday, October 10, 2016, and the criminal draw on October 24, 2016. Magistrate Judge Ruiz will also participate with all of the other eastern division magistrate judges in the Magistrate Judge Arraignment Protocol.

In order to establish a docket for the new magistrate judge, the reference of cases that had been referred to Magistrate Judge Kenneth S. McHargh, whose retirement was effective on September 30, 2016, are hereby withdrawn and referred to Magistrate Judge Ruiz. (List of referred cases needing reassignment attached.)


Any civil or criminal cases in which Magistrate Judge Ruiz was active while serving as an Assistant United States Attorney will be randomly reassigned to other magistrate judges pursuant to the Court's case assignment protocol. Any social security cases on Magistrate Judge McHargh's docket filed prior to June 8, 2016, will be reassigned to other magistrate judges throughout the district pursuant to the Court's case assignment protocol.

In addition, in order to facilitate the efficient and timely administration of justice, consent is withdrawn from cases remaining on Magistrate Judge McHargh's consent docket and are returned to the previously assigned district judge, and the cases are hereby referred to Magistrate Judge David A. Ruiz. If the parties wish to consent to the jurisdiction of Magistrate Judge David A. Ruiz, pursuant to

28 U.S.C. Section 636(c), they should complete and electronically file with the Clerk of Court a Consent to Exercise Jurisdiction by a United States Magistrate Judge form by Monday, October 17, 2016. (List of consent cases needing reassignment attached.)
