
At the regular judges' meeting of the Court held on December 8, 2014, the Court approved the appointment of the attached list of attorneys to serve on the Federal Court Panel.

In February, 2013, the Court requested that the Northern District of Ohio Advisory Group and its Alternative Dispute Resolution (ADR) Subcommittee make a recommendation regarding the size of the Federal Court Panel. The Advisory Group's recommendation to reduce the size of the ADR Panel to approximately 100 members by January 2015 due to the diminishing number of cases being referred to Federal Court Panel members was approved at the February 3, 2014 Judges' Meeting. Per the Advisory Group's recommendation, letters were issued to Panel members in April, 2014 requesting members who wished to continue serving reapply.

Local Civil Rule 16.4 authorizes the establishment of the Federal Court Panel, consisting of persons who, by experience, training, and character, are qualified to act as evaluators, mediators, arbitrators, or other neutrals. The Court considered the attached list of 95 applicants and approved their appointment to a three-year term which will expire on December 31, 2017.
