The typical Cleveland courtroom diagram shows only one amplifier.

The bid sheets for all seven typical Cleveland courtrooms have a QTY of one for the QSC CX204V, except 19B which shows a quantity of two.

**THE SPECIFIC QUESTION IS**: Should we quote the quantity for the QSC CX204V that is shown on each bid sheet (one on 18A, 18B, 17A, 15A, 15B & 16A and two on 19B)?
