The Programmer Analyst provides administrative and technical support to the court in a wide range of areas, including developing and configuring hardware and software programs and providing support for technology projects. Programmer Analyst performs work related to designing, modifying and adapting existing system software, coding and testing, as well as troubleshooting for hardware and software systems. This position analyzes end-users' needs and develops and implements solutions. Promotion potential to CL 27 without further competition.

Duties and Responsibilities include, but are not limited to the following:

- Plan, develop and implement software applications and systems for the court which enhance organizational efficiency and capabilities. Confers and collaborates with IT management team and end users to gather system requirements and design and implement plans, enhancements, testing, maintenance and training.
- Modify, adapt, enhance, and implement existing software, including national programs and locally developed automated systems.
- Assist with technical support of the court's web sites, including underlying structures, web pages, and/or applications. Assist IT team with web development, operation and maintenance of web sites and pages using web technologies and programming languages.
- Develop custom informational and statistical reports for multiple departments of the court. Perform programming and system enhancements, testing, and create system documentation.
- Create, maintain, and enhance Java, Perl and Linux scripts, data/form libraries, and applications using a variety of web-based software.
- Provide support for database structures, including Informix, SQL Server, and MySQL.
