The United States Department of the Interior has submitted, pursuant to Local Criminal Rule 58.2(d), a revised fine schedule for National Park Service offenses at the Cuyahoga Valley National Park and Perry's Victory and International Peace Memorial.

General Order No. 93-03 is hereby superseded and vacated.

Persons charged in this district with violating an offense listed in the following fine schedule for National Park Service offenses at the Cuyahoga Valley National Park and Perry's Victory and International Peace Memorial may, in lieu of appearance, post collateral (fine) in the amount indicated for the offense and consent to the fine.

Upon the recommendation of the Committee on Civil and Criminal Practice and Rules, a majority of the judges of this Court, by mail vote taken pursuant to Eighth Amended Administrative Order No. 95-22, approved the attached list of fine schedule for National Park Service offenses at the Cuyahoga Valley National Park and Perry's Victory and International Peace Memorial.
