District Judge Dan Aaron Polster has appointed Ankura Consulting Group to assist in the Multidistrict Litigation In re: National Prescription Opiate Litigation, Case No. 1:17-md-2804, and has requested PACER fee exemptions for Ed Bell, Mark King, Jennifer Alpert, John Hays, Dennis Delmott, Gabriela Varela, and Carlos Bustos (the "Applicants") in order to assist the Court.

Accordingly, the Applicants shall be exempt from the payment of fees for access via PACER to the electronic case files maintained in this Court to the extent such use is incurred in the course of conducting research for this Multidistrict Litigation matter. They shall not be exempt from the payment of fees incurred in connection with other uses of the PACER system in this Court.

Additionally, the following limitations apply:

1. This fee exemption applies only to the Applicants and is valid only for the purposes stated above.
2. This fee exemption applies only to the electronic case files of this Court that are available through the PACER system.
3. By accepting this exemption, the applicants agree not to sell for profit any data obtained as a result of receiving this exemption.
4. The applicants are prohibited from transferring any data obtained as a result of receiving this exemption, including redistribution via internet based databases.
5. These exemptions are valid until the conclusion of this Multidistrict Litigation matter.

These exemptions may be revoked at the discretion of the Court at any time. A copy of this Order shall be sent to the PACER Service Center, which should provide applicants PACER accounts with a fee exemption to access the records of the U.S. District Court for the Northern District of Ohio for:
