Pursuant to Administrative Order 2020-03, Carmen E. Henderson has been selected as the new magistrate judge for the U.S. District Court for the Northern District of Ohio and will be located in Youngstown, Ohio. Magistrate Judge Henderson entered on duty July 1, 2020, and shall be placed on the civil, social security, and habeas corpus case draws on July 10, 2020, and the criminal draw on July 24, 2020. In addition, in order to facilitate the efficient and timely administration of justice, consent is withdrawn from cases remaining on Magistrate Judge Limbert's consent docket and are returned to the previously assigned district judge, and the cases are hereby referred to Magistrate Judge Carmen E. Henderson.

If the parties wish to consent to the jurisdiction of Magistrate Judge Carmen E. Henderson, pursuant to 28 U.S.C. Section 636(c), they should complete and electronically file with the Clerk of Court a Consent to Exercise Jurisdiction by a United States Magistrate Judge form by July 17, 2020. (List of consent cases needing reassignment attached.)
