Pursuant to Administrative Order No. 2021-13, Amanda M. Knapp has been selected as the new magistrate judge for the U.S. District Court for the Northern District of Ohio and will be located in Akron, Ohio.

Magistrate Judge Knapp will assume the Akron "Duty Magistrate Judge" responsibilities beginning October 5, 2021. Magistrate Judge Carmen E. Henderson has agreed to cover the Akron "Duty Magistrate Judge" responsibilities on October 1, 2021 through October 4, 2021.

#### **Case Assignment Draws**

Magistrate Judge Knapp will be placed on the magistrate judge social security, civil, criminal, and habeas corpus case draws on October 5, 2021. Magistrate Judge Knapp will also participate with all of the other Eastern Division magistrate judges in the Magistrate Judge Arraignment Protocol.

In order to establish a docket for the new magistrate judge, the reference of cases that had been referred to Magistrate Judge Kathleen B. Burke, whose retirement was effective on September 30, 2021, are hereby withdrawn and referred to Magistrate Judge Knapp. (List of referred cases needing reassignment attached.)

In addition, in order to facilitate the efficient and timely administration of justice, consent is withdrawn from cases remaining on Magistrate Judge Burke's consent docket and are returned to the previously assigned district judge, and the cases are hereby referred to Magistrate Judge Amanda M. Knapp.

If the parties wish to consent to the jurisdiction of Magistrate Judge Amanda M. Knapp, pursuant to 28 U.S.C. Section 636(c), they should complete and electronically file with the Clerk of Court a Consent to Exercise Jurisdiction by a United States Magistrate Judge form by October 18, 2021. (List of consent cases needing reassignment attached.)

On August 5, 2021 Magistrate Judge Kathleen B. Burke was removed from the magistrate judge civil case draws in anticipation of her retirement. For rebalancing purposes, each magistrate judge may transfer the number of cases as listed below to Magistrate Judge Knapp that were filed between August 5, 2021 and September 30, 2021.
