Pursuant to Administrative Order No. 2022-11, Jennifer Dowdell Armstrong has been selected as the new magistrate judge for the U.S. District Court for the Northern District of Ohio and will be located in Cleveland, Ohio.

In order to establish a docket for the new magistrate judge, the reference of cases that had been referred to Magistrate Judge William H. 

If the parties wish to consent to the jurisdiction of Magistrate Judge Jennifer Dowdell Armstrong, pursuant to 28 U.S.C. Section 636(c), they should complete and electronically file with the Clerk of Court a Consent to Exercise Jurisdiction by a United States Magistrate Judge form by September 15, 2022. Magistrate Judge Armstrong will assume and be reassigned to any magistrate judge case where Judge Baughman was the presiding or assigned magistrate judge.
