Pursuant to Administrative Order No. 2022-12, James E. Grimes Jr. has been selected as the new magistrate judge for the U.S. District Court for the Northern District of Ohio and will be located in Cleveland, Ohio.

#### **Case Assignment Draws**

Magistrate Judge Grimes will be placed on the magistrate judge social security, civil, criminal, and habeas corpus case draws on September 16, 2022. Magistrate Judge Grimes will also participate with all of the other Eastern Division magistrate judges in the Magistrate Judge Arraignment Protocol.

#### **Case Reassignment and Rebalancing**

At the time the Honorable David A. Ruiz was sworn-in to serve as a U.S. District Judge in Cleveland, he was removed from the magistrate judge draw. Further, all pending social security and habeas corpus matters that had been referred to Judge Ruiz in his role as a magistrate judge were randomly reassigned and automatically referred to a magistrate judge. For rebalancing purposes, each magistrate judge may transfer the number of cases as listed below to Magistrate Grimes.

Finally, 305 general civil cases were drawn from the Cleveland deck between February 11, 2022 and August 25, 2022 and assigned to a Cleveland magistrate judge. For purposes of rebalancing, 79 of these cases were randomly selected for reassignment to Magistrate Judge Grimes. (List of general civil cases to be reassigned is attached.)

Magistrate judges must submit their lists of cases they wish to transfer to Magistrate Judge Grimes to the Clerk of Court by the close of business on October 3, 2022.

Magistrate Judge Grimes will assume and be reassigned to any magistrate judge case where Judge Ruiz was the presiding or assigned magistrate judge.

#### Consent

If the parties wish to consent to the jurisdiction of Magistrate Judge James E. Grimes Jr. pursuant to 28 U.S.C. Section 636(c), they should complete and electronically file with the Clerk of Court a Consent to Exercise Jurisdiction by a United States Magistrate Judge form by October 10, 2022.
