Due to the retirement of Magistrate Judge Thomas M. Parker on March 24, 2024, consent is withdrawn from the cases listed in Exhibit A, which were on his consent docket, and are returned to the previously assigned district judge. If the parties wish to consent to the jurisdiction of a magistrate judge, pursuant to 28 U.S.C. Section 636(c), they should complete and electronically file with the Clerk of Court a Consent to Exercise Jurisdiction by a United States Magistrate Judge form ("Consent").

If a Consent not contained in Exhibit A is filed prior to the filling of the vacancy ("the Vacancy") created by the retirement of Magistrate Judge Thomas M. Parker, on a case where he was the assigned magistrate judge, said case will be reassigned to Magistrate Judge Jonathan D. Greenberg as the presider.

If a Consent not contained in Exhibit A is filed after the filling of the Vacancy, on a case where Magistrate Judge Thomas M. Parker was the assigned magistrate judge, said case will be returned to the previously assigned district judge.

Any Consents to Magistrate Judge Jonathan D. Greenberg, which occur as a result of this Order, will be returned to the previously assigned district judge after the Vacancy has been filled. If the parties wish to re-consent to the jurisdiction of the new magistrate judge, pursuant to 28 U.S.C. Section 636(c), they should complete and electronically file with the Clerk of Court a Consent to Exercise Jurisdiction by a United States Magistrate Judge form.

The pending referrals to Magistrate Judge Thomas M. Parker listed in Exhibit B to this Order shall be referred to Magistrate Judge Jonathan D. Greenberg for all proceedings consistent with such referral pending the filling of the Vacancy.

Any new referrals for cases not listed in Exhibit B, where Magistrate Judge Thomas M. Parker was the assigned magistrate judge, will be referred to Magistrate Judge Jonathan D. Greenberg until the Vacancy has been filled.

Any pending referrals to Magistrate Judge Jonathan D. Greenberg, which occur as a result of this Order, will be withdrawn and re-referred to the new magistrate judge once the Vacancy has been filled.

A notation shall be entered on the docket for each case affected by this Order, noting the reassignment, reinstatement of reference, or reassignment of reference.
