**THIRD AMENDMENT BY INTERLINEATION  
TO AMENDED CASE MANAGEMENT ORDER NO. 13**

**(ESTABLISHING DEPUY ORTHOPAEDICS, INC. ASR HIP IMPLANT FEE AND  
EXPENSE FUNDS TO COMPENSATE AND REIMBURSE ATTORNEYS FOR  
SERVICES PERFORMED AND EXPENSES INCURRED FOR MDL  
ADMINISTRATION AND THE COMMON BENEFIT)**

**I. SCOPE OF THIS ORDER**

This Order is an interlineation to Section II.A of Amended Case Management Order No 13, as amended, (“CMO 13”) and is entered to name an additional escrow agent for purposes of this Order.

**II. JPMORGAN CHASE BANK, NA**

Amended Case Management Order No. 13 provides for Adele Jasion, CPA, and Kevin Gilmore, CPA, of Gilmore, Jasion & Mahler, Ltd. to serve as the Escrow Agent for the Fee and Expense Funds established under this Order. This stipulation by interlineation to CMO 13, as amended, is intended to add JPMORGAN CHASE BANK, NA as an additional designated

Escrow Agent for purposes of Amended Case Management Order No. 13, with respect to disbursement under this Order for those assessment accounts established under the DePuy ASR Settlement Escrow Agreement approved by this Court in Case Management Order 19, as amended.

Interlineation to Section II.A, Establishing the Fee and Expense Funds, on page 3 of Amended Case Management Order No. 13 is hereby made as follows:

**A. Establishing the Fee and Expense Funds.** Plaintiffs' Liaison Counsel ("PLC") is directed to establish two interest bearing accounts to receive and disburse funds as provided in this Order (the "Funds"). The first fund shall be designated the "ASR Hip Fee Fund" and the second fund shall be designated the "ASR Hip Expense Fund." These funds will be held subject to the direction of this Court. These funds will be held subject to the direction of this Court. Adele Jasion, CPA, and/or Kevin Gilmore, CPA, of the firm of Gilmore, Jasion & Mahler ("Escrow Agents") are hereby appointed as escrow agents for the purpose of receiving and disbursing funds as provided in this Order. JPMORGAN CHASE BANK, NA is hereby appointed an escrow agent for the purposes of disbursing funds as provided in this Order with respect to the accounts established the DePuy ASR Settlement Escrow Agreement as adopted by this Court in Case Management Order 19, as amended.
