Given the fact that this ASR litigation has been pending for a substantial period of time and given the fact that the ASR Settlement Agreement dated November 19, 2013 establishing the U.S. Settlement Program likely will result in a pool of ongoing litigation that will be substantially smaller, the Court finds that it is time to focus more intensively on the individual claims in this MDL 2197. This Order shall apply to all Plaintiffs listed on the attached Exhibit A who have undergone Revision Surgery^[1] on or before August 31, 2013 with claims in MDL Docket No. 2197 (“Plaintiff” or “Plaintiffs”) *unless* the claim is eligible for, and has been enrolled in, the U.S. Settlement Program.^[2] This Order does not apply to current Plaintiffs who did not have a Revision Surgery on or prior to August 31, 2013.

I. PRESERVATION NOTICE REQUIREMENT

A. Within sixty (60) days of the entry of this Order, counsel for a Plaintiff subject to this Order shall notify the following individuals or entities, by registered or certified mail, that they may have information relevant to the Plaintiff’s claim in this MDL Proceeding (“Claim”) and that any records, lab results, radiology, pathology, or explanted components relating to the Plaintiff must be preserved (the “Notice”), pending collection by the Plaintiff:

1. All orthopaedic surgeons who treated the Plaintiff during the period from January 1, 2000 to the present;
2. All hospitals or medical facilities at which the Plaintiff had orthopedic surgery for the period from January 1, 2000 to the present;
3. All individuals or entities providing storage facilities which have or have had

possession of any explanted ASR component or re-revision component; and

4. If Plaintiff is seeking lost wages, all of his or her employers for the period from three years prior to the date for which he is seeking lost wages through the last day for which Plaintiff is seeking lost wages.

B. All copies of the Notice shall be preserved by counsel for Plaintiff for so long as the Claim remains pending in this Proceeding, and shall be timely provided to defense counsel.

II. DISCOVERY REQUIREMENTS

A. All Plaintiffs on Exhibit A subject to this order must produce all of the information described in this Section II to counsel for the Defendants within sixty (60) days from the Date of this Order:

1. All medical records relating to the Plaintiff from all healthcare providers in possession of plaintiffs' counsel. This specifically includes all medical records from all orthopedic surgeons who have treated the Plaintiff, copies of all x-rays and the complete hospital charts for all implant and revision surgeries.

B. All plaintiffs subject to this Order shall appear for deposition starting September 1, 2014.

C. Nothing in this Order abrogates or replaces each Plaintiff's obligation to submit the Plaintiff's Preliminary Disclosure or Plaintiff Fact Sheet, authorizations and other materials required under Case Management Order No. 5 and Amended Case Management Order No. 9. Plaintiffs need not re-submit a Plaintiff Fact Sheet if one has already been submitted with respect to his or her Claim; however, if supplementation is required to ensure the accuracy of a previously served Plaintiff Fact Sheet, such supplementation must be completed within the time frames set forth above.
