The U.S. District Court for the Northern District of Ohio is comprised of eleven authorized District Judgeships, three senior judges, and seven magistrate judges. The Northern District of Ohio is headquartered in Cleveland and has divisional offices in Akron, Toledo and Youngstown. The Pretrial Services & Probation Office has an opening for a Supervisory U.S. Pretrial Services & Probation Officer in Toledo, Ohio.

POSITION SUMMARY:

A supervising officer is a first line supervisor responsible for the quantity and quality of pretrial and probation services provided by office staff in the full range of operations (pretrial services, presentence investigations and supervision), requirements, and services to the court and public. The duty station for this position is Toledo, Ohio, however, incumbent may supervise staff in multiple offices. The incumbent will initially supervise a unit of Pretrial Service and Presentence officers.

A Supervisory Probation Officer must have the capability to manage a professional staff of six or more, including establishing standards, evaluating performance, handling minor infractions, recommending disciplinary actions, and conferring regularly to provide direction and assistance in case situations and with general operational procedures and local policies. Incumbent must have the skills to train and coach staff, and effectively audit and review work. The incumbent leads by example and demonstrates mature judgment, technical excellence, policy execution, staff development, and maintains a service-based viewpoint.

QUALIFICATIONS: (Qualifications must be met at the time of application)

EDUCATION

Completion of a Bachelor's degree from an accredited college or university with major in criminal justice, criminology, psychology, sociology, human relations, business or public administration **is required**. An advanced degree is preferred. Bilingual (i.e. Spanish, Arabic, etc.) is preferred but not required.

REQUIRED EXPERIENCE

To qualify at the CL 29 level, candidate <u>must all requirements of a federal law enforcement officer</u> and have at least three years of specialized experience, <u>including at least one year as a CL 28 pretrial</u>

<u>services/probation officer in the U.S. Courts</u>. To qualify at the CL 30 level, candidate must have at least three years of specialized experience, <u>including at least one year as a CL 29 pretrial/probation services</u> <u>officer in the U.S. Courts</u>.

SPECIALIZED EXPERIENCE

Specialized experience is progressively responsible experience gained after completion of a qualified bachelor's degree in such fields as probation, pretrial services, parole, criminal investigations, or work in substance/addiction treatment. (Experience as a police, custodial, or security officer does not qualify as specialized experience.)

CONDITIONS OF EMPLOYMENT:

Applicants must be U.S. citizens or eligible to work in the United States. A background investigation with law enforcement agencies, including fingerprint and criminal, financial, and employment record checks will be conducted. Officers are subject to periodic completion of the investigation and random drug testing.
